

## San Diego USATF Board of Directors Meeting

2. Minutes from August 2017 approved with corrections. Minutes from January 2018 were approved with corrections.
3. President's Report
  - a) SafeSport message from the National Office: All officials and volunteers at meets need to have completed SafeSport, be USATF members, and get a background check. It's on the Association to follow these guidelines. The Youth Committee brought up the importance of the entire Board being compliant with the USATF guidelines that both the Officials and Youth follow (USATF member, Safesport, Background Check) as technically without meeting the requirements you aren't eligible to be a Board Member. The Youth have been very diligent in making sure that all coaches and volunteers meet the requirements, the Board needs to ensure that they are all as well.
  - b) The Association T&F Championships will be held in conjunction with a meet at the CVEATC.
